ON 10/15/08 I MADE CONTACT WITH FBI AGENT [REDACTED] AT THE REQUEST OF SGT. [REDACTED]. HE ADVISED THAT THEY HAD LOCATED THE VICTIM OF A BATTERY THAT HAD OCCURRED IN FT. SMITH EARLIER THIS YEAR. AT THE TIME OF THE INCIDENT THE VICTIM WAS 17 YRS OLD. I MET WITH HIM AND AGENT [REDACTED] AT A SPECIFIED LOCATION WHERE I WAS INTRODUCED TO [REDACTED] WHO IS NOW 18 YRS OLD. I TOOK A RECORDED STATEMENT FROM HIM.

[REDACTED] TOLD ME THAT HIS PARENTS ARE [REDACTED]. HE HAD LIVED WITH THE TONY ALAMO FOUNDATION WITH HIS PARENTS BUT HAD RECENTLY LEFT. HIS PARENTS AND ONE SISTER REMAIN THERE. HE HAD BEEN DOING HOME-SCHOOLING UNDER THE ABECA CURRICULUM BUT DROPPED OUT IN THE MIDDLE OF THE 10TH GRADE. I ASKED HIM TO TELL ME WHAT HAPPENED.

[REDACTED] SAID HE HAD BEEN ABUSED BY JOHN KOLBECK. HE HAD KNOWN OF THIS MAN SINCE HE WAS A KID AND MAY HAVE SPENT THE NIGHT AT HIS HOUSE ON ONE OCCASION. HE SAID THAT THE FIRST TIME IT HAPPENED IT WAS AT THE GYM AT THE COMPOUND IN FOUKE. THE SECOND TIME WAS AT THE WAREHOUSE ON 4TH STREET IN FT. SMITH. HE WAS STAYING IN A ROOM THERE AND HELPED OUT WITH THE SALVAGE BUSINESS THEY HAD THERE.

[REDACTED] TOLD ME IT WAS AROUND JANUARY OR FEBRUARY OF THIS YEAR. HE SAID IT WAS COLD AT THAT TIME. SOMEONE HAD TOLD HIM HE LOOKED LIKE HARRY POTTER. HE SAID HE MADE A SARCASTIC REMARK ABOUT HARRY POTTER TO A PERSON WHO WROTE HIM UP AND REPORTED IT TO TONY ALAMO. HE SAID HE TRIED TO TELL THEM HE WAS NOT EVEN SERIOUS BUT ON THE NEXT DAY OR SO HE GOT 'BEAT'. HE WAS ON THE PHONE WITH HIS DAD WHEN [REDACTED] WALKED IN AND GRABBED A HOLD OF HIM. [REDACTED] TOLD HIM HE WAS ONLY FOLLOWING ORDERS. THEN JOHN KOLBECK WALKED IN AND ACCUSED HIM OF TRYING TO RUN AWAY. [REDACTED] TOLD HIM HE WASN'T AND KOLBECK CALLED HIM A LIAR. KOLBECK THEN BEGAN SLAPPING HIM IN THE FACE WITH AN OPEN HAND. [REDACTED] SAID HE WAS HIT AT LEAST 10 TIMES. KOLBECK TOOK HIS ARM AND TWISTED IT BEHIND HIS BACK AT WHICH TIME HE WALKED HIM INTO THE MAIN WAREHOUSE. HE HAD [REDACTED] GET ON HIS KNEES. [REDACTED] HELD HIM DOWN AGAIN. KOLBECK'S 'BOYS', WHICH INCLUDED HIS SONS, WERE ALSO PRESENT. KOLBECK HAD HIM STRETCH OUT ON THE FLOOR ON HIS BELLY. HE SAID HIS CHIN HIT THE FLOOR AND IT SPLIT OPEN. KOLBECK THEN BEGAN TO STRICK HIM NUMEROUS TIMES WITH A BOARD. HE SAID KOLBECK WOULD BE STANDING UP AND HOLDING THE BOARD WITH BOTH HANDS, HITTING HIM WITH THE FLAT SIDE. HE HIT HIM ABOUT 20 TIMES, TAKING HIS TIME BETWEEN EACH ONE, TAUNTING HIM AND ASKING QUESTIONS SOMETIMES ABOUT STUPID THINGS. [REDACTED] SAID HE HAD THERMALS ON AND KOLBECK THOUGHT THAT WAS INTERFERING WITH THE PUNISHMENT. THEY PULLED HIS PANTS AND THERMALS DOWN TO HIS UNDERWEAR. KOLBECK STRUCK HIM 5-7 MORE TIMES. THE BOARD BROKE WHILE HE WAS HITTING [REDACTED]. THEN KOLBECK ACTED NICE AND TOLD [REDACTED] TO GO CLEAN HIM UP, TELLING HIM TO TAKE A BATH BECAUSE IT WOULD HELP HIM.

[REDACTED] SAID THAT HIS BUTT WAS BLEEDING FROM THE BROKEN SKIN FOR ABOUT A WEEK, AND IT OOZED. HE HAD BRUISES THAT WERE BLACK, BLUE, PURPLE, AND HE EVEN HAD HARD LUMPS IN THE SKIN. HE DID NOT RECEIVE ANY TREATMENT FOR IT AND HE STILL HAS SOME BRUISING FROM THAT INCIDENT. HE SAID HE DIDN'T HAVE MANY MARKS FROM THE SLAPS TO THE FACE BUT STILL HAS THE SCAR ON HIS CHIN FROM WHERE IT HIT THE FLOOR. HE WAS WITH HIS PARENTS AFTER THIS HAPPENED THOUGH HE WAS TOLD NOT TO.

[REDACTED] TOLD ME THAT THE TIME HE GOT BEAT IN FOUKE WAS 10 TIMES WORSE. HIS FACE WAS SWOLLEN AND BLEEDING. HIS BUTT WAS BRUISED AND BLEEDING. ON ANOTHER TIME, A WHILE BACK, HE WAS GOING TO GET BEAT BUT HE RAN OFF. NOTHING HAPPENED THAT TIME AND HE WENT TO FT. SMITH.

[REDACTED] SAID THAT HE SAW HIS DAD GET BEAT AT FOUKE IN THE PAST. HIS DAD CHOSE A BEATING OVER LEAVING THE CHURCH. KOLBECK BROKE THE BOARD ON HIS DAD TOO, BUT CONTINUED TO HIT HIM WITH ONE OF THE PIECES. HIS DAD ALSO GOT BEAT AT THE GYM AT THE SCHOOL ON WINDSOR THE DAY BEFORE HE GOT BEAT. HE SAID KOLBECK HIT HIM ABOUT 30 TIMES. HE HAS SEEN THE MARKS ON HIS DAD. SETH TOLD US THAT HE KNEW THAT SOME OF HIS FRIENDS GOT BEAT TOO. HE DIDN'T SEE IT

HAPPEN BUT SAW THE MARKS RIGHT AFTER IT HAPPENED. HE TALKED ABOUT [REDACTED] AND [REDACTED]. HE SAID HE WAS NOT SURE ABOUT [REDACTED]. [REDACTED] IS LIVING IN ANOTHER STATE BUT [REDACTED] IS STILL IN THE CHURCH EVEN THOUGH HE HAD LEFT TO GET AWAY FROM A BEATING. HE HAS ALSO HEARD THAT OTHERS GOT BEAT BUT HE COULD NOT PROVIDE THOSE NAMES. [REDACTED] WILL BE GOING TO LIVE WITH OTHER FAMILY MEMBERS IN ANOTHER STATE. HE HAD NOTHING FURTHER TO OFFER SO THE INTERVIEW WAS CONCLUDED.

I RETURNED TO THE OFFICE AND LOOKED UP JOHN KOLBECK. I FOUND HIS DATE OF BIRTH TO BE 09/23/59. HE HAD TWO ENTRIES IN ICIS AND BOTH LISTED AN ADDRESS OF 3201 SPRADLING.

AGENTS [REDACTED] AND [REDACTED] MET WITH ME AT THE PD. I WAS TOLD THAT AT FIRST [REDACTED] WAS VERY RELUCTANT TO TALK TO THEM. THEY HAVE BEEN TAUGHT THAT LAW ENFORCEMENT WAS EVIL AND HE THOUGHT HE WAS GOING TO BE IN TROUBLE FOR SOMETHING. ONCE HE UNDERSTOOD THAT HE WAS NOT IN TROUBLE HE BEGAN TO TELL THEM ABOUT WHAT HAPPENED. THEY HAD TAKEN SOME PHOTOS OF THE BRUISING STILL VISIBLE ON [REDACTED] BUTTOCKS. THEY PUT IT ON A CD AND I DOWNLOADED THE IMAGES ON MY COMPUTER. THE PHOTOS WERE QUITE DARK BUT A LARGE BRUISE WAS STILL VISIBLE. I ASKED THEM TO GET SOME BRIGHTER PHOTOS AND THEY SAID THEY WOULD.

I WAS ADVISED THAT MR. KOLBECK'S LAST KNOWN ADDRESS IS 110 NO. 16TH, BUT HE HAS NOT BEEN OBSERVED THERE SINCE THE SEARCH WARRANT WAS SERVED ON THE COMPOUND IN FOUKE. THEY PROVIDED THE ADDRESS OF THE WAREHOUSE WHERE [REDACTED] HAD LIVED AND WHERE HE WAS INJURED AS 800 SO. 4TH.

AGENTS [REDACTED] AND [REDACTED] LEFT BUT RETURNED A SHORT WHILE LATER WITH 2 ADDITIONAL CDS CONTAINING PICTURES OF [REDACTED]. THESE WERE ALSO DOWNLOADED ONTO MY COMPUTER AND THE PHOTOS WERE MUCH BRIGHTER. THE BRUISING CAN STILL BE SEEN. THERE ARE ALSO PHOTOS OF THE SCAR ON [REDACTED] CHIN.

I WAS PROVIDED WITH COPIES OF STATEMENTS FROM [REDACTED] WHO WAS ABUSED BY KOLBECK IN FOUKE, AND FROM [REDACTED] WHO WAS TAKEN FROM FT. SMITH TO KOLBECK'S HOME IN OKLAHOMA AND BEATEN. BOTH OF THOSE BOYS NAMED [REDACTED] AS A VICTIM OF BEATINGS AS WELL.

ALSO INCLUDED WERE STATEMENTS FROM TWO WITNESSES. [REDACTED] SAID HER SISTER [REDACTED] WAS BEATEN WITH A BOARD. SHE TALKED ABOUT JOHN KOLBECK ADMINISTERING 'PUNISHMENT' UPON THE CHURCH MEMBERS, AND RECALLED KOLBECK PUNISHING [REDACTED] IN FT. SMITH. IF ANY KIDS ACT UP KOLBECK IS TO BEAT THEM. HE HAD STRUCK [REDACTED] WITH A FIST. [REDACTED] HAD BEEN BEATEN HERSELF, BUT BY OTHER MEMBERS. [REDACTED] SAID ALAMO ORDERED HER TO BE BEATEN WHILE AT FOUKE. ALAMO YELLED HE WAS GOING TO GET JOHN KOLBECK TO BEAT HER BUT ENDED UP HAVING ONE OF HIS WIVES DO IT. SHE HAD WITNESSED THE BEATINGS OF [REDACTED], [REDACTED], AND [REDACTED]. ALAMO HAD WANTED THE OTHER KIDS TO WATCH WHILE KOLBECK PUNCHED THE KIDS IN THE FACE AND THEN HIT THEM WITH A BIG BOARD. THEY WERE NOT ALLOWED TO GO TO CHURCH SERVICES UNTIL THEY HEALED.

THIS MORNING I TOOK A COPY OF THIS REPORT TO THE P.A. OFFICE WHERE I MET WITH CDPA DANNY SHUE AND DPA GRAHAM JONES. I REVIEWED THE MATTER WITH THEM AND WE DISCUSSED THE SITUATION. AS A RESULT OF OUR CONVERSATION I SIGNED AN AFFIDAVIT FOR A WARRANT FOR THE ARREST OF JOHN KOLBECK FOR SECOND DEGREE BATTERY WITH A BOND OF \$50,000.00 CASH. AFTER WADING THROUGH THE LACK OF AVAILABLE JUDGES AND GLITCHES IN THE COUNTY'S COMPUTER SYSTEM, THE WARRANT WAS FINALLY SIGNED AND ACTIVATED. I TOOK THE ORIGINAL TO THE S.O. WARRANT OFFICE AND ASKED THAT IT BE ENTERED N.C.I.C. WHICH THEY DID IMMEDIATELY. I CONTACTED FBI AGENT [REDACTED] AND MADE HIM AWARE THAT THE WARRANT WAS ISSUED, AND FAXED HIM A COPY AS HE REQUESTED. I ALSO NOTIFIED [REDACTED] BY EMAIL.
